### **SESSION DATES**

June 30th - August 6th 2020 The debate on the indigenous peoples' rights raises on a socio-legal management of this. This requires (i) interpreting the legislation from human rights approach, (ii) being part of an intercultural debate (local and global) in planning state action, and (iii) reading the sociocultural circumstances of each country. In this sense, skills and competences based on the recognition of ethnic identity and cultural diversity must be promoted to contribute to the design of intercultural public policies. Particularly understand legal pluralism as a central element of cultural diversity and public management.

The course contributes with learning and reflection on not only the reality of indigenous people, but above all it aims to recognize the possibilities of an adequate exercise of the collective rights of indigenous people. The course will have a global perspective but will pay attention to the Peruvian case.

#### AT THE END OF THE COURSE, YOU WILL BE CAPABLE OF:

- Analyze how the state addresses the actual problems of indigenous people, incorporating human rights and interculturality approaches.
- Describe the concepts of culture and interculturality as the theoretical basis for working on indigenous peoples' issues.
- Explain the historical antecedents that build indigenous peoples as a subject of law in the international arena.
- Describe the content of the main human rights instruments regarding indigenous peoples.
- Use the theoretical content of legal pluralism to analyze practical cases.
- Identify how to incorporate the intercultural approach in state action with indigenous people.



## **Teaching methodology**

• The methodological proposal is characterized by being active and participatory, and by encouraging self-learning and autonomy. The integration and exchange of ideas among students in virtual spaces is promoted. The methodological strategy is to identify the progress made by the student. For this, a series of activities has been proposed according to the topics of the course, which are sustained in the review of the reading material and videos chosen by the specialist professor for each of the topics. In this way, the student will carry out learning activities on virtual platforms (Zoom and Google classroom) such as discussions about the lectures and videos provided.
