

# Pandemics, Global History and Peruvian Society

The history of humanity has been marked by wars, revolutions, natural disasters, and pandemics. Pandemics, although less studied, have been responsible for significant changes in history. For example, the fall of the Incan Empire was largely a consequence of the deaths produced by diseases brought by the Spaniards, such as smallpox and measles. During the nineteenth century cholera and yellow fever pandemics led to important urban reforms and the development of public health institutions in Peru. Pandemics are not a thing of the past. In the XXIst century evils like dengue, malaria, HIV or Ebola are causing human and economic losses globally.

This course will analyze the origins, social responses, state responses, and consequences of the main epidemics and pandemics that have occurred in modern history. The course will have a global perspective but will pay attention to the Peruvian case.

He is currently professor at the PUCP and Director of the Riva-Agüero Institute.

- 7. Tuberculosis and social determinants of health.
- 8. The Amazonian region and Tropical Medicine
- 9. High-altitude diseases and nationalism
- 10. Pregnancy and childbirth: medical transformations

#### AT THE END OF THE COURSE, YOU WILL BE CAPABLE OF:

- Analyze the impact of pandemics in human history.
- Explain the origins of the main pandemics that plagued humanity in modern history with an emphasis in Peru.
- Understand social responses, which usually combine: panic, exacerbation of prejudice (especially against minority or foreign groups), skepticism and conspiracy theories.
- Examine the complex relationship between scientists and politicians when responding to pandemics.
- Describe the historical contexts that allowed for pandemics to thrive.



## **Teaching methods**

- The course will combine an expository part provided by the teachers and a constructive methodology supported by exercises based on primary sources by the students. Likewise, based on the course topics and the primary sources worked on throughout the course, students will have to prepare an exposition based on an original work. Participants will work in groups and individually.
- The course will include virtual interactive classes via Zoom, in-class discussions, YouTube videos, audiovisual material and the use of academic texts.
